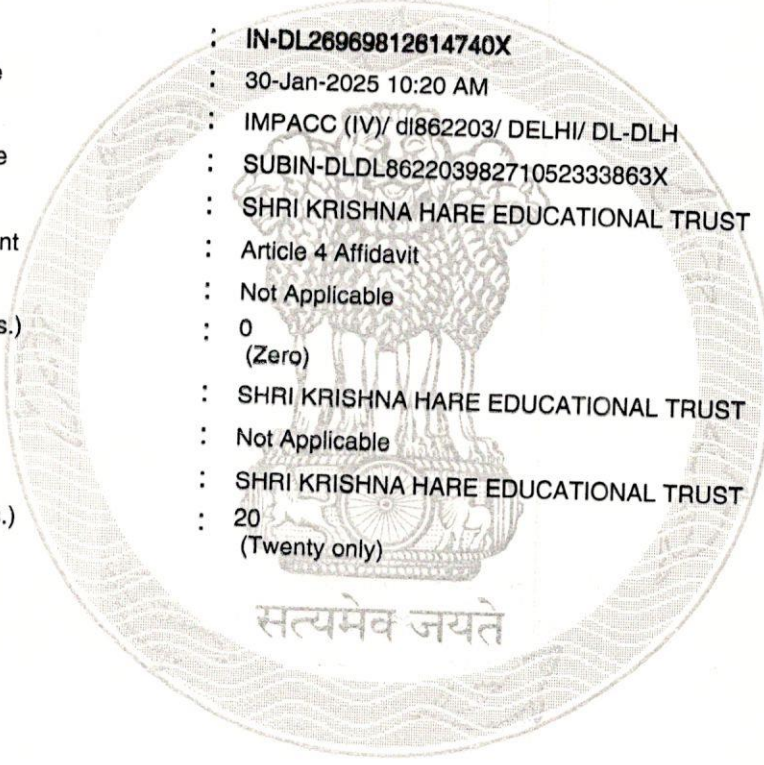






1. That **Shri Krishna Hare Educational Trust** is a registered Trust under the **Indian Trusts Act 1882**.

6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

That the Principal and Correspondent/Manager of the School have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time.
